Booking and Cancellation Policy

DEPOSITS & CANCELLATIONS

To secure a reservation at Echo Valley Ranch, a 20% deposit is required at time of booking. The balance of payment is due 30 days before arrival. Bookings received within 30 days require full pre-payment.

The following refund schedule applies to all bookings/cancellations:

60 + days before arrival: Full refund

59 - 30 days before arrival: 20% deposit retained

29 - 0 days before arrival: No refund

All cancellations must be received in writing.

In cases of cancellation, it will be at Echo Valley Ranch & Spa's discretion to offer equivalent credit for a rescheduled stay.

Echo Valley Ranch & Spa cannot be held responsible for delays caused by Acts of God, strikes, weather, aircraft delays or other causes beyond its reasonable control.

COVID-19 CLAUSE

Should guests be unable to travel to Echo Valley Ranch & Spa due to travel restrictions implemented regarding the COVID-19 Pandemic, a full refund will be issued for cancellations up to 24 hours prior to arrival. This is only applicable for COVID-19 related restrictions, such as border closures or flight cancellations, as well as government travel advisories.

Full prepayment 30 days prior to arrival still applies as specified above but will be refunded within 48 hours in case of cancellation as outlined.

CHECK IN AND OUT

Check in time is 2:30 pm unless arranged otherwise.

Check out time is 11:00 am unless otherwise arranged.

No arrival at the ranch after 9:00 pm unless arranged prior. There is no 24-hour reception desk.

CHILDREN

The ranch experience is best suited for guests 10 years or older and as such, 10 years is the minimum age for a stay in Echo Valley. For exclusive bookings (use of the entire ranch) children of any age are welcome.

FORCE MAJEURE AND PACKAGE CHANGES

Echo Valley Ranch & Spa will endeavour to provide all services as shown in the Package description, however, all activities are subject to weather conditions and may be cancelled, postponed or changed at the sole discretion of EVR. In case of force majeure such as flight cancellations or delays, travel disruptions, weather delays or forces beyond its control EVR is not liable to refund any monies paid. The 2021 COVID-19 CLAUSE applies as described above.

HORSEBACK RIDING WEIGHT RESTRICTIONS

The maximum weight for riding is 200 lbs., or at the wrangler's discretion.

INSURANCE

It is strongly recommended that guests take out cancellation and interruption insurance.

MINIMUM LENGTH OF STAY

The minimum length of stay is 2 nights.
